It's hard to describe the change I've watched in **Marlon and Bridgy Sierra** over the last 2-3 months. I have been training this couple for 2 years, and training them intensely in Deaf ministry for the last 12 months. Now that my departure is confirmed they have become significantly more motivated to reach the deaf, develop a deaf ministry, and train others to do the same. Upon learning I would be leaving, their first words were, "Don't worry about us, God has called us to reach the deaf, whether you're here or not we will obey God." They have demonstrated their commitment to God and to reaching this forgotten people group by requesting more classes from me, and finding ways to visit Deaf people even when I'm not available. They have paid the price in a small way already, with trials that were too timely to be coincidental, and more trials – as well as blessings! – are yet to come. But our God is able.
